1. <u>Background and Need.</u>

As part of my plan to streamline state government and make it more efficient, I have asked my staff to conduct a review of the 300 boards, commissions and advisory committees authorized by executive order and state statute. After a thorough review of the above named bodies that were created by executive orders, I have determined that they have fulfilled the mission and the duties envisioned by the original executive orders forming those bodies. I extend my thanks to the participants on these advisory bodies for their work on behalf of the State of Colorado.

2. <u>Mission and Scope.</u>

Boards, commissions and advisory committees are asked to undertake discrete charges through direction by executive order. The above named bodies have accomplished their designated missions. Therefore, I hereby order that the above named boards, commissions and advisory committees be decommissioned.

3. Past Executive Orders Superceded and Replaced.

This Executive Order shall supercede and replace all previous executive orders pertaining to the above named boards, commissions and advisory committees.

4. Duration.

This Executive Order shall remain in effect until further modification or rescission by the Governor.
